AMENDED ORDER FOR SERVICE BY PUBLICATION

The trial shall be held before the Honorable Tim Barnes, Judge for the Montgomery County Juvenile Court. Failing to appear for the hearing on this date and time, without good cause, pursuant to Rule 39(c)(3) of the Tenn. R. Juv. P. will result in the loss of your right to contest the petition. You may view and obtain a copy of the Petition and any other subsequently filed legal documents at the Montgomery County Juvenile Court Clerk's Office located at 2 Millennium Plaza, Clarksville, TN 37040.
