Their publication policy is to publish the Order, any notices, and all court-issued documents continuously for a period of three (3) consecutive weeks.

This method allows for a greater opportunity to give actual notice to the known father, Michael Graco Castilla, Respondent, than service by publication in a traditional newspaper. It provides publication of the Court Order, plus the entire set of Court- issued documents. Further, the publication period exceeds the customary once a week for three (3) consecutive weeks by continually publishing the documents for an indefinite period, as allowed by law or necessity. In addition, a Google search by the Respondent's name and country will typically appear on page one of the Google search after approximately five (5) days, thus, providing a greater opportunity to give actual notice to the Respondent, the unknown father.
