ORDER ALLOWING ALTERNATIVE SERVICE BY PUBLICATION

NOW ON THIS 29th day of December, 2023 the matter comes before the Court on the Nation's Motion for Publication. The Court considers the Nation's Motion and the facts alleged in the Petition for Termination of Parental Rights of Natural (Putative) Father and Unknown Father. The Court finds that the whereabouts of the Natural (Putative) Father are unknown and that based upon information and belief, the Natural (Putative) Father is residing in Mexico.

The Court therefore Orders that service be executed against the Natural (Putative) Father, Carlos Quintana by publication in GlobalLegalNotices.com, which is a newspaper of general circulation in Mexico near the Natural (Putative) Father, Carlos Quintana. This publication shall be once every week for four weeks consecutively which exceeds statutory publication requirements.




