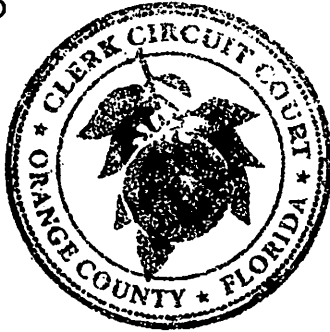

**PETITION FOR DISSOLUTION OF MARRIAGE WITH NO MINOR CHILDREN OR  
PROPERTY**

**COMES NOW**, the Petitioner/Wife, **ZENAIDA B. MENDEZ PEREZ**, by and through his undersigned counsel, hereby files this Petition for Dissolution of Marriage With Minor Children and Other Relief, and states as follows:

1. **ACTION FOR DISSOLUTION OF MARRIAGE:** This is an action for dissolution of marriage between the Petitioner/Wife, **ZENAIDA B. MENDEZ PEREZ**, (“Wife”), and the Respondent/Husband, **ARCELIO LINARES VALDES**, (“Husband”).
2. **RESIDENCY AND JURISDICTION:** Both the Husband and Wife have been a resident of the State of Florida for more than six (6) months prior to filing of this Petition for Dissolution of Marriage. The parties last resided together as Husband and Wife in Lake County, Florida.
3. **GROUND:** The marriage of the parties is irretrievably broken.
4. **MARRIAGE:** The parties were married on October 18, 2002 in Cuba.
5. **DATE OF SEPERATION:** The parties separated on or around August 1, 2011.
6. **MILITARY SERVICE DECLARATIONS:** In accordance with the provisions of the “2003 Servicemembers Civil Relief Act” and its subsequent amendments, Wife has investigated the statues of the Husband and determined the Husband is not now serving in the Armed Forces of the United States or any branch thereof, nor has the Husband served in the Armed Forces of the United States of any branch thereof within thirty (30) days immediately preceding the date of this Petition; Husband has not been ordered to report for the service in the

Armed Forces of the United States or any branch thereof or for the induction into the Armed Forces of the United States or any branch thereof at the date of this Petition.

7. SOCIAL SECURITY NUMBER: The Social Security number of the Wife is listed in a separate document titled "Notice of Filing of Social Security Number," which is being filed concurrently with this Petition.

8. SPOUSAL SUPPORT: Wife waives all claims for spousal support.

9. REAL PROPERTY: The Husband and Wife have no real property.

10. PERSONAL PROPERTY: Husband and Wife have no joint personal property.

11. DEBTS: Husband and Wife have no joint debt.

12. MAIDEN/FORMER NAME: The Wife is not requesting a name change.

13. MANDATORY DISCLOSURE: Wife requests that mandatory disclosure be waived.


14. ATTORNEY'S FEES AND COSTS: The Wife is not requesting attorney fees or costs.

**WHEREFORE**, The Petitioner/Wife, **ZENAIDA B. MENDEZ PEREZ**, respectfully requests that this Honorable Court:

- A. Take jurisdiction of the parties and the subject matter thereto;
- B. Award Wife the relief sought herein, and dissolve the marriage of the parties;
- C. Grant any other relief the court deems just and proper.

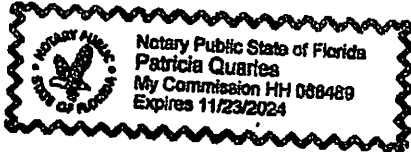

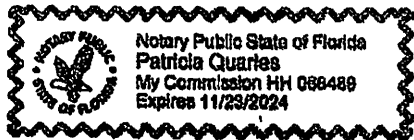

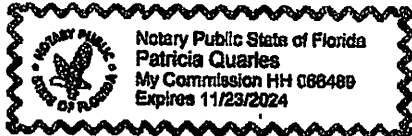
